192 people attended events at the Chew Street Community Center



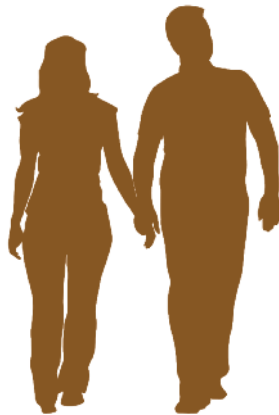
2 babies saved from abortion

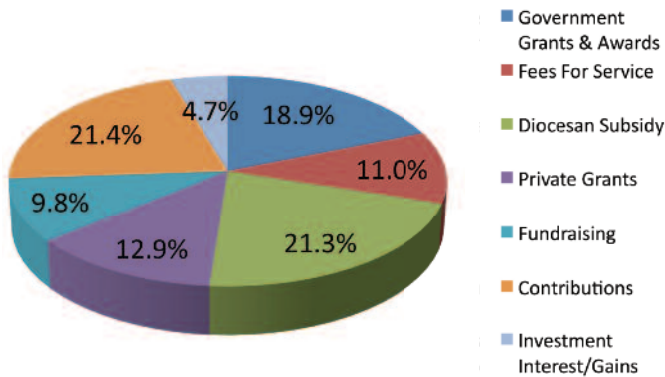

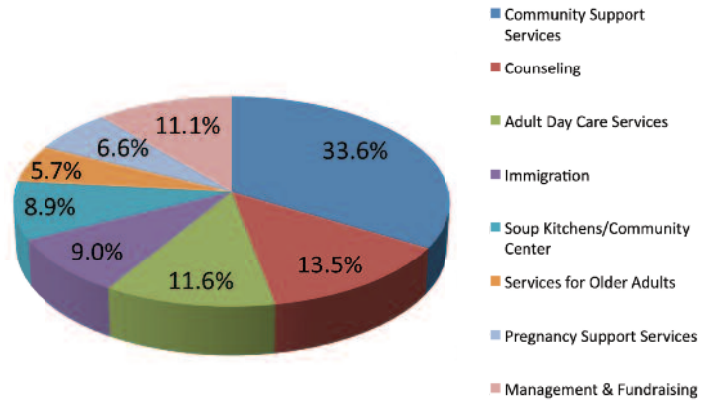
